

It is our pleasure to share with you the first edition of the Principles for Peace newsletter. In this edition, we share key highlights and progress about the various lines of engagements of the initiative and ongoing efforts of the International Commission on Inclusive Peace (ICIP) and partner organisations.

The case for our collective effort is growing with the persistent increase in violent conflicts and the developing fatigue with repeated failures of current systems, which underline the pressing need to consultations and innovative and

reshape approaches to building sustaining peace. From Afghanistan to the Middle east to the Sahel, the frustration of people whose lives, hopes and futures are at stake, batter against the paralysis of the international system with ever greater clarity. Your collective leadership in reimagining and realising a new international approach to peace is paramount.

Since the launch of the ICIP, the initiative has gained momentum and the backing of an increasing number of Member States and over 27 peacebuilding, development, and humanitarian organisations joining the Stakeholder Platform.

The Stockholm Forum

The ICIP led a high-level panel on "Shifting the peace paradigm: power and responsibility" during this year's Stockholm Forum on Peace and Development, 5-7 May. The panel featured members of the ICIP **Annika Söder. Bert Koenders**.

The Stakeholder Platform | convened for the first time in March 2021. The convening brought together over 50 participants representing 27 partners, including organisations. peacebuilding and security women peace organisations, UN entities, research institutions, five member states and the EU. Eight members of the ICIP joined the meeting to discuss the findings of country consultations conducted

Search for Common Ground and country case studies commissioned to TRIAS as part of the P4P initiative. International Alert presented their Peace Perceptions Poll from 2018 to inform the development of the Principles for Peace.

Broadening the outreach, the P4P intensified outreach to Member States and extended an invitation to all ambassadors in Geneva to engage in the initiative. The Afghan

government expressed interest in a dialogue with the International Commission on the Afghan Peace process and planned withdrawal.

General Roméo Dallaire briefed the Government of Canada and invited their support to the initiative.

The China Foreign Affairs University is the latest institution to join the initiative's evidence partnerships.

A Collective Effort: Lines of Engagement

The ICIP launches three of the thematic lines of effort in partnership with co-conveners who will facilitate global and local consultations.

Local ownership & responsibility:

P4P is partnering with Peace **Direct** for a series of consultations with over 100 representatives of local organisations leveraging the Platform4Dialogue

In line with the iterative process and to avoid narrowing the conversation, the consultations will begin with definitions: i.e., What does peace look like? What does local ownership What does national mean? responsibility look like? Subsequent conversations will build on this to begin identifying the pragmatic barriers for achieving greater local ownership and responsibility. The

lead commissioner and the keynote listeners for the theme are Teresita Quintos Deles and Yves Daccord.

Sustainability & long-term solutions:

The lead commissioner for this theme is Bert Koenders. The iterative process will kick-off with a series of global consultation coorganised with UNDP, national and global partners that will bring together a group of nexus actors from various countries. The conversation will focus on a set of practical dilemmas on how to achieve more sustainable peace efforts.

Stabilisation & security actors:

Led by General Romeo Dallaire. This theme is being launched with a Transatlantic Dialogue on rethinking stabilisation organised by Interpeace and the Atlantic Council. The first session on bridging the civil-military divide will see a keynote address by General Roméo Dallaire. Sanam Naraghi-Anderlini will take part in the same panel. Bert Koenders, meanwhile, will moderate a panel focusing on partnerships for stabilisation operations. Ambassador Frederic Gateretse Ngoga will join a panel on improving multilateral stabilisation operations for people in conflict.

The Centre on Conflict, Development & Peacebuilding (CCDP) at the Graduate Institute Geneva have partnered with P4P to collaborate on various themes of engagement.

Engaging Youth

Ilwad Elman leads global youth engagement in the P4P initiative. activists, peacebuilders and networks will gather in global and thematic consultations to share what peace means to them and what it ought to deliver. P4P will collaborate with Search for Common Ground on this line of engagement.

July, Throughout June

bi-weekly online sessions will invite representatives from Commission, Member Intergovernmental organisations and the United Nations to serve keynote listeners to youth representatives. The consultations will build on the Youth, Peace and Security agenda and focus questions will be structured around the key dilemmas emerging from the thematic lines of engagement.



Engaging Parliamentarians

(IPU) standing Committee on Peace and International Security adopted a proposal for a resolution in support of rethinking peace processes.

The Inter-Parliamentary Union's Two regional consultations with parliamentarians will take place later this year and a dedicated panel is planned at the IPU General Assembly in Kigali.

Engaging Countries

partnership for Common Ground and International Alert, an initial round of 85 participatory consultations were completed in Afghanistan, the Central African Republic, Myanmar, Nigeria, Sierra Leone, Syria, Ukraine, and Yemen.

The results of the consultations will feed into the work of the Commission. The consultations highlighted the need to build social peace at all levels of society. As a respondent in Afghanistan remarked:

"Political peace alone is not enough. Political peace is not lasting without peace in the lower strata of society".

The P4P Secretariat commissioned three initial country case studies to illustrate some of the dilemmas of peace processes. In the Sudan and Northern Ireland case studies, TRIAS highlights the inadequacy of a political settlement approach to building positive peace.

In **Northern Ireland**, the case study showed that while the powersharing agreements put in place through the Good Friday Agreement process have been extremely successful in eliminating violent conflict, they seem to perpetuate and rigidify the identities in conflict which contributes to continued sectarianism and segregation.

In Sudan, the Juba peace process has resulted in agreements on security arrangements and powersharing, while the complexities of governance, transitional justice, accountability, and development shifted to the implementation phase.

Inclusive Peace completed a case study on Aceh-Indonesia. The case study points to the centrality of local ownership to durable peace.

Engaging the Public

Together with our partner **Purpose**, P4P is developing a global campaign that will help to build momentum by engaging local communities and targeting global decision makers. Innovative and creative tactics, the

Content

The Iterative **Process**

The first meeting of the International Commission for Inclusive Peace January 2021 identified six key thematic areas that will be employed as themes to start the iterative development of the principles. The themes are pluralism, sustainability & long-term solutions, stabilisation & security actors, local ownership and responsibility, tools, institutionalisation & norms diffusion, and values and cultural integrity. The themes serve as initial entry points to identify key problems and good practices in peacebuilding and peace-making.

The iterative process will make use of various sources of evidence through a review of existing literature, by commissioning case studies on specific contexts and questions, by hosting incubation spaces and simulations to get

pragmatic considerations affecting real or realistic scenarios. The consultations with different constituencies and in regional and country contexts will be key to the process. Keynote listeners from the thematic working groups will carry key messages emerging from consultations back to the working groups that will be composed of research and practice organisations and lead commissioners.

P4P is in the process of setting up a research committee as an internal peer review mechanism for the ICIP outputs. To that end. a long list of more than 25 eminent scholars in the field of peace and conflict studies was compiled. The Secretariat is currently approaching the scholars with an invitation to

address the gap between evidence and practice and to support the iterative process with evidence, the P4P secretariat team has started reviewing relevant academic and practitioner literature. Thus far, the team has reviewed starters are currently under revision

more than 110 pieces of literature which will eventually be put in a public catalogue.

Based on this review, the team has drafted brief summaries on the state of play and practical dilemmas relating to sustainability & longterm solutions, local ownership & responsibility, and stabilisation & security actors. These conversation by lead organisations and academic partners.

Based on initial conversations with the Commission co-chairs, P4P has also commissioned an options paper to be drafted by **Graduate Institute** of Geneva on the objectives of the initiative and where the principles should land and anchor in the international system.
